Open Letter to the NJGOP Leadership

The following is an open letter to the New Jersey Grand Old Party (**NJGOP**) pointing out some serious matters confronting the residents of New Jersey. These issues are not being addressed or even taken seriously by our State Government, neither Democrat nor Republican. Here's a portion of the preamble of the New Jersey Constitution as a preface to this letter:

"We, the people of the State of New Jersey, grateful to Almighty God for the civil and religious liberty which He hath so long permitted us to enjoy and looking to Him for a blessing upon our endeavors to secure and transmit the same unimpaired to succeeding generations, do ordain and establish this Constitution."

It seems that our rights, which are granted by Almighty God, have now been abused to the point where our state government feels it is best to Rule over the citizens rather than Represent our will and our voice. We are told *what* we will do, *when* we will do it and *how much* the government will be extorting from us in the name of taxation. Our state government needs to be reminded that they have been elected and swore an oath to protect OUR rights as described in the Constitution of New Jersey. This constitution protects the rights of the people; it is not a decree of how these elected officials will exercise their will over the people so that we have no choice but to obey. That would be tyranny!

I am submitting this letter to the NJGOP because I believe that your organization's interests mostly lie in helping the people of this state. I challenge NJGOP to see whether this is fact or if our government in New Jersey is, as many suspect, a "two party illusion." Will the GOP of New Jersey listen to their constituents and stand up for them, or merely point their fingers at the Democrats and claim their hands are tied? I am asking for your help getting the following important issues brought to the table for discussion and action.

ELECTIONS

Why have none of the Republicans in our state taken a serious stance on the 2020, 2021 and 2022 elections? The voters in New Jersey are educated and aware - we are not "deniers" as the state sponsored media label us. We demand - and will continue to demand - hand counted paper ballots, single day voting, and a requirement to prove identification to vote.

There are serious issues with the black box computers we use for elections. It is not even possible that we can be shown the "real" results.

- Why is the Department of Homeland Security involved in our elections and when did they become federalized?
- If the voting machines that we use are not connected to the internet or "other networks" then why are we constantly told that Russia, China, Pakistan, Ukraine, Iran and so many others are hacking or trying to hack our elections?

The voter rolls in New Jersey must be cleaned up and verified. Accurate voter rolls could prove that New Jersey is indeed a “red state.”

- Where is the push back from Republicans on giving voting rights to 17-year-olds in the primaries? Primaries are just as important as the General Elections. Which party benefits most from younger, indoctrinated voters? Not the NJGOP.
- Why is NJDMV registering non-citizens to vote when applying for a driver’s license? What “deals” have been made to allow this?

Mass mail-in ballots must be stopped immediately. Mail-in and absentee voting is much less secure than in-person voting.

- What is the NJGOP doing to reduce the number of disenfranchised voters due to late or missing ballots and unverified signatures?
- How is the Union within the USPS complicit (knowingly or unknowingly) in skewing our election results?

The citizens of New Jersey deserve same day voting with ID on hand-counted paper ballots.

WELCOMING AMERICA

I do not consent to the use of my tax dollars to fund the relocation and support of illegal immigrants in New Jersey.

- Is the NJGOP aware that some of our churches and religious NGOs are housing, moving and aiding many of the people coming across our borders illegally? What are you doing to expose and stop this activity?
- How are Republicans involved in development programs for small airports in New Jersey, including any special “deals” with Delaware companies to move people and products around?

PUBLIC INFORMATION

In recent years, NJ residents have begun increasingly submitting “OPRA” and “FOIA” requests. However, those requests have been consistently denied. We need transparency, not excuses.

- What is NJGOP doing to help their constituents access the information they are entitled to?
- How will your organization help clarify why our elected representatives are meeting with the United Nations and the World Health Organization? Are they agreeing to things on behalf of NJ citizens? We must have transparency about ‘arrangements’ that may have been made without the knowledge or consent of the people of New Jersey.

ACCOUNTABILITY ABOUT COVID 19

I believe many people in New Jersey were falsely coerced into taking medical actions that are unconstitutional.

- When will any Republican stand up and demand an investigation into the overreach of Governor Murphy and the Department of Health during the pandemic?
- Why have the Republicans remained silent about accountability regarding the mandates (that are not law) and the physically injured or financially damaged?

THE SMITH-MUNDT MODERNIZATION ACT OF 2013

The Smith-Mundt Modernization Act was bundled into the National Defense Authorization Act, which passed and was signed by President Obama in 2013. "Modernization" meant the prior propaganda protections for US citizens were dropped. This allowed government agencies and bureaucrats to create media "news" and opinion using taxpayer funding. Americans are now bombarded daily with contrived narratives from government entities, globalist corporations and various lobbyists.

- This must be stopped in New Jersey; the people of our state deserve the truth. If mainstream media continues to do nothing more than gaslight the public, they should lose their broadcasting licenses and be held accountable for damages.
